Each year the Mid-South District PSSA, the South Coast PSSA, and, when required, the Southern Illawarra Zone, hold trials for representative sporting teams. The sports available this year include:

Lake Illawarra South Public School is invited to nominate representatives to attend the trial in each sport at a District level. These trials will occur at various times throughout Terms 1 and 2. If a student is selected to represent the Mid-South District team, they are then given the opportunity to be selected in the Southern Illawarra Zone (if applicable), South Coast PSSA and NSW PSSA teams.

To assist the teachers at Lake Illawarra South Public School to nominate the best students for these sporting teams, we would like you to complete the 'Expression of Interest to Trial' form attached. Please clearly indicate the sport your child has experience playing outside of school and the level they have achieved.

Not all students who nominate for these teams will be selected to trial. In some circumstances, teachers will run a trial at school to select the students who will attend the District trial.

PLEASE NOTE: Students must play this sport outside of school with a local club or be classified as highly skilled to be considered to attend a trial.

Unfortunately, in some cases, not enough students nominate for a trial to go ahead. In these circumstances, we will do our best to find a different District's trial/team for students to join.

It is up to parent/guardian supervisors to transport students to and from selections. If selected, please note there may be a cost or travel involved if chosen to represent at a higher level.

Students and families are responsible for obtaining trial information from our weekly assemblies and newsletters. There are often short notice periods that must be adhered to, including returning permission notes quickly and on time. **No note = no trial. In 2021, the Mid South District will apply this policy to ALL sporting events.**

Please complete the nomination form and **return to Mrs Smith no later than Wednesday 3rd February 2021** if you wish your child to be considered for selection for representative trials in 2021. This information is for Mid-South District trials only. Teachers will run separate trials for PSSA Knockout Teams in 2021.
